Introduction

In 2019 we asked you what you thought about our ideas for an **Additional Learning Needs Code**.

Chapter 31 of the ALN Code

Chapter 31 is about what should happen when:



 a young person aged between 16 and 25 years old



- or parents of a child aged 0 to 15 years old,





Mental capacity means being able to make your own decision about something at the right time.

If you do not have **mental capacity**, it means you are not able to make certain decisions.



It is important that young people and parents are involved in decisions about their lives. Or their child's life.



Here are our ideas to support young people and parents when they are not able to make a decision for themselves.

Our ideas for Chapter 31





Young people and parents who do not have mental capacity should have a representative.



A representative is a person who will have all the information about a decision that needs to be made.

They will help to make the decision and stand up for the rights of the young person or parent.



A representative could be someone that has already been chosen by the Court to make decisions for the person.



If a young person does not have a representative chosen by the Court, their **parent** could be their representative.



We think this would work well because a parent:



• is likely to understand their child's ALN



- and want to make the best decisions for them.



Professionals who work with the young person or parent should help them get a representative, if they need one.



The representative should always support the rights, thoughts and feelings of the young person or parent.



A representative can:

 make decisions for a young person or child's parent



 go to meetings and take part in writing plans for the young person or child



 deal with forms and other paperwork about the young person or child



make an appeal to the Education Tribunal.
This is when you ask a special panel to look at a decision again, because you do not agree with it.



In the ALN Code we will talk about the young person and the child's parent.



When we say **young person** in the ALN Code we want it to mean:

representative or

young person and their representative.



When we say **parent** in the ALN Code we want it to mean:

representative or



parent and their representative.



We want this to be the same in:

the Additional Learning Needs and Education
Tribunal (Wales) Act 2018



 and the Equality Act 2010 – where it talks about things to do with the ALN Code.
