

## APPRENTICESHIPS – LEARNER

### ENTRANT GUIDELINES

Recognising the commitment and high level skills of those individuals who have chosen the Apprenticeship Programme as a route to success.

Entries should demonstrate one or more of the following:

- Proven commitment by an apprentice to continued personal development.
- An apprentice who has contributed significantly to the business and provided added value.
- An apprentice who has demonstrated a high level of skills and/or has contributed significantly to the sector within which they work.
- The “distance travelled” by the apprentice to succeed in their chosen field.

#### Foundation Apprentice of the Year (NVQ Level 2 equivalent)

To apply for this award you must have:

- Completed a Foundation Apprenticeship Framework in Wales (evidence of certification will be required prior to any judging decision being made).
- Completed it no earlier than 1 August 2020, with actual or expected completion no later than 31 July 2022.

#### Apprentice of the Year (NVQ Level 3 equivalent)

To apply for this award you must have:

- Completed an Apprenticeship Framework in Wales (evidence of certification will be required prior to any judging decision being made).
- Completed it no earlier than 1 August 2020, with actual or expected completion no later than 31 July 2022.

#### Higher Apprentice of the Year, including Degree Apprentices (Level 4 or higher)

To apply for this award you must have:

- Completed a Higher or Degree Apprenticeship Framework in Wales (evidence of certification will be required prior to any judging decision being made).
- Completed it no earlier than 1 August 2020, with actual or expected completion no later than 31 July 2022.

**Q2. Please provide details of any learning programme you were on (including qualifications you achieved) prior to starting your apprenticeship**

**Q3. Describe your Apprenticeship Programme (up to 250 words)**

You might think of including information on:

- Why you decided to undertake an apprenticeship.
- Your learning programme.
- Any barriers you faced and successfully overcame either prior to or during your Apprenticeship Programme.

**Section 5:** Your story – to be completed by the apprentice.

**Q4. Please tell us three things about how your apprenticeship has contributed to your employer's business success (up to 400 words)**

You might think of including information (and examples) on:

- Any measurable outcomes that have been achieved as a result of your contribution. For example, a percentage increase in sales and/ or profitability, more efficient ways of working, better staff morale etc. Please provide statistics and/or evidence that demonstrates the impact you, as an apprentice, have had on the business.
- Where you have promoted learning, taken the initiative and/or demonstrated entrepreneurial skills.

**Q5. Please describe the personal progress you have made during your Apprenticeship Programme (up to 400 words)**

You might think of including information on:

- Your current employment status.
- Any personal outcomes, related to your Apprenticeship Programme, which have been achieved, for example skills competitions entered, opportunity to work across your sector etc.
- Improvements to your confidence, self-esteem, employability as a result of undertaking your Apprenticeship.

**Q6. Please describe your commitment to your learning and the outcomes you have achieved (up to 400 words)**

You might think of including information on:

- How you have pro-actively challenged yourself, and how you have strived to be recognised for excellence in relation to your learning and skills.
- Any further learning undertaken (or planned) as a result of undertaking your Apprenticeship.

**Q7. Please detail how your learning has enabled you to contribute to your employer's objectives/business plan or even via the development of your own business (up to 400 words)**

You might think of including information (and examples) on:

- Any measurable outcomes that have been achieved as a result of your contribution, for example increased sales/profitability, more efficient ways of working, better staff morale.
- Where you have promoted learning, taken the initiative and/or demonstrated entrepreneurial skills.

**Section 6:** Employer endorsement – this section is to be completed by the employer.

**Q8. Why, in your opinion, should this individual be considered for an Apprentice of the Year Award? (up to 250 words)**

You might think of including information (and examples):

- On the contribution made by the individual to the organisation.
- Of how the individual has overcome barriers in undertaking their Apprenticeship Framework.

- Of how the individual has consistently challenged themselves (and others) in undertaking their Apprenticeship Programme.
- What makes them stand out from the crowd.

**Section 7:** Declaration – to be completed by the apprentice.
