"I joined Welsh Government in 2014 after working as a Senior Lecturer at the College of Law, and University of South Wales. I'd specialised in Constitutional and Administrative Law, but wanted to do it rather than just talk about it! Since joining, I've been able to work on things that just wouldn't come across your desk elsewhere - like the Miller case on Article 50 TFEU, which was the first time the entire Supreme Court bench had sat; various National Assembly Bills; a major constitutional Bill going through the UK Parliament (the Wales Act 2017); and judicial review cases. I love what I do - it's challenging, varied and there is room to be creative as you're working at the margins of a developing constitutional settlement. It's also a great place to work with flexible hours, a good annual leave allowance and social activities like Wednesday night 5-a-side."

"I moved to Welsh Government Legal Services in 2014 from GLD (TSol as then was), where I'd spent time advising several different Whitehall Departments. Quality of life and cost of living on this side of Offa's Dyke were factors in our decision to leave London, but my wife (another Government lawyer!) and I were principally drawn to the opportunity of working in a more compact organisation. Working previously for the State Government of Victoria (Australia), I had particularly liked the greater sense of proximity to the strategic operation of Government as a whole and opportunities for working across-Government offered by an organisation of this size.

Those hopes have absolutely been borne out by my experience since joining - first as Team Leader for the lawyers advising the Counsel General directly on a huge range of matters, and latterly as Team Leader of Energy and Environment. With a portfolio of responsibilities in the team equivalent to roughly half of DEFRA plus bits of BEIS, all our lawyers carry substantial individual responsibility, but (I hope!) find the breadth and variety of exposure which this provides stimulating and satisfying. I certainly enjoy working with such bright and kind colleagues."

"Before joining the Commercial and Public Contracts Team in the Welsh Government's Legal Services Department, I spent over 5 years working at Blake Morgan - initially as a trainee solicitor and later qualifying into the firm's Commercial team. In private practice I had a large number of public sector clients and regularly advised them on contract and procurement matters. I started to become curious about what it would be like to work in-house so when a vacancy arose at the Welsh Government as a commercial and procurement lawyer, I decided to explore it further. I really enjoyed working in private practice but I've never regretted the move to the Welsh Government.

I've been part of Legal Services for three years now and I've had the opportunity to be involved in some very interesting work during this time. Some of my work is similar to the type of work I did in private practice but a lot of it is brand new such as working on legislation and contributing to submissions to Ministers. It's been nice to have a new challenge and I've had plenty of support and encouragement to develop new skills. There are lots of opportunities for learning and development.

My colleagues are also fantastic and hugely supportive. I returned to work in January following maternity leave. Legal Services has been very flexible and didn't hesitate in allowing me to adjust my days and hours to balance work with my new family commitments. My colleagues work a variety of working patterns and I feel confident that I will be supported to achieve the work/life balance I want too."

Prior to joining the Welsh Government, I worked in a number of public sector roles, specialising in Commercial Property.

The work is varied and continues to engage my interest. One moment you could be working on the acquisition of a factory in Mid Wales and the next, attending an auction for the sale of surplus properties.

The work is challenging at times, and provides the opportunity to develop new skills and work with different teams, both in Legal Services and the wider Welsh Government. I have worked with Legal colleagues on changes to Compulsory Purchase legislation and with the Economy and Creative Industries team on work relating to the filming sector. During the Coronavirus initial lockdown period, our team was engaged with legal work relating to the setting up of the Bay Studios as a field hospital, lettings of units for the storage of PPE and moving a standalone facility from the Royal Glamorgan Hospital to one of the units we owned nearby.

Welsh Government offers flexible working arrangements and the Property Team I work in is friendly and supportive and you are encouraged to expand your skills and knowledge.

I joined the Welsh Government in 2006, when the former Welsh Development Agency was merged with the then named National Assembly for Wales. Previously, I had worked within the property teams of 2 Local Authorities. I initially joined as an Assistant Commercial Property Lawyer and was a Certified Fellow of the Institute of Legal Executives. With the support of the Welsh Government, I was able to study and qualify as a solicitor. This enabled me to apply for and successfully gain promotion as a Commercial Property Lawyer in 2010.

The work that we undertake as a team is very varied. Our internal clients include Economic Infrastructure, , Transport, Regeneration, Housing, Cadw and Health. We are involved in the various legal agreements that are required as part of site assembly for commercial and residential developments. We draft and advise on grant funding agreements in respect of the construction or redevelopment of buildings. We assist our clients with the estate management of the various land and buildings that form part of the Welsh Government portfolio and which are let on a short or long term basis, either by way of a lease or a Farm Business Tenancy or Grazing Licence. We also provide advice to Ministers and colleagues within other legal teams, where there is a property element involved.

We are a busy team and the work certainly keeps us on our toes but it does allow you to obtain a good work/life balance.

Commercial and Public Contracts Team Lawyer



Before joining the Commercial and Public Contracts team in Welsh Government Legal Services, I had been working since qualification as a banking and finance lawyer in private practice in London and then at Eversheds Sutherland in Cardiff. I know that working as a lawyer for Welsh Government wouldn't even occur to many people working in the commercial/finance/corporate spheres in private practice as there may be a perception that the in-house legal work in Welsh Government revolves around public law, but think again! Whilst there is of course a sizeable multi-disciplinary public law team, what many people don't realise is that there are also dedicated in-house commercial teams which cover a vast set of specialist areas such as commercial contracts, finance arrangements, IT/IP, commercial property and many more. If you are looking for a change from private practice or other in-house commercial role, I would recommend that you give a role in Welsh Government Legal Services some serious consideration.

The work is very interesting and varied, and I have been involved in some fascinating projects since joining the team – many of these have been similar to my work in private practice, but it has been interesting to learn about specific areas and issues which are relevant to Welsh Government and which may impact on the commercial arrangements it enters into. I am still learning new things each day, and have been fortunate to work on several high profile matters; whilst these may have, on occasion, been challenging (be it because of the urgency or complexity of the work), it has been rewarding to see the results of our work coming into effect as various deals and projects complete across Wales. The support I receive from my colleagues is excellent, and it is such a friendly place to work – despite starting my role during the pandemic and therefore never having had the opportunity to work in an office with my team, I have been made to feel incredibly welcome from day one.

My work/life balance has also improved significantly since I joined the team – I have been able say farewell to timesheets, billing targets, and the (sometimes) long hours, whilst saying "hello" to more predictable working hours and a much healthier work/life balance. I completely enjoy the role, and only wished I had looked into this sort of opportunity years ago! I would encourage anyone else who may be interested in applying for this opportunity to give it some serious consideration, and go for it.

Legal Services Department and its Values

Over 100 lawyers and support staff provide legal advice and legislative drafting services to Ministers across all Welsh Government Cabinet portfolios.

The department consists of 22 legal subject teams which largely reflect the Welsh Government's Cabinet portfolios.

The teams are:

Those legal team portfolios are designated by the Director of Legal Services, and may be the subject of change from time to time to reflect the wider organisation of the Welsh Government, the business needs of the office or to facilitate professional development within the office.

Government Lawyers report to and support the posts of the Senior Government Lawyers and Deputy Directors of Legal Services.

As a Government Lawyer, you will be part of a large team responsible for the delivery of all legal services to the Welsh Government.

The services provided by the department include advice on complex matters of public and commercial law, the drafting of instructions to the Office of Legislative Counsel (the Welsh Government's equivalent of Parliamentary Counsel's Office), the drafting of primary legislation, the preparation of all Welsh Government subordinate legislation, the handling of high profile litigation and the drafting of a wide variety of commercial agreements.

The Legal Services Department's Management Board provides strategic leadership and is collectively responsible for delivering the department's organisational objectives. It plays a key role in ensuring that the department is equipped to provide a professional, efficient and high quality service in accordance with the department's values of being connected, enabling and committed, and in accordance with the department's vision of "professionalism, impartiality, excellence".

The Role

The positions available are for Government Lawyers (Commercial and Property Teams), as we look to expand these teams.

Key Responsibilities

For Public Law teams (excluding Property and Commercial teams) For all teams

- Prepare, or assist

 in the production of, full instructions for
 primary legislation either relating to Bills
 forming part of the Welsh Government's
 legislative programme or relating to
 Welsh provisions in UK Parliamentary
 Bills.
- Draft, or assist in drafting, a range of subordinate legislation and other formal documentation within the team portfolio and to monitor its passage through Senedd procedures as necessary.

- Provide and contribute to the provision of legal advice within a team portfolio.
- Contribute to the effective delivery of services within the team portfolio.
- Contribute to the team and ensure responsiveness to customer/client's needs and changing circumstances.
- Undertake such other duties, responsibilities, tasks or projects as are specified by the Team Leader or a Deputy Director of Legal Services which are commensurate with the level of the post.
- Provide support and cover for colleagues within the office as directed by the Team Leader or a Deputy Director of Legal Services.
