Item 1: Minutes of the previous meeting

1.1 Cymeradwyodd y Cabinet gofnodion y 15 Ebrill / Cabinet approved the minutes of 15 April.

Item 2: First Minister's Items

First Minister's engagements that week.

2.1 The First Minister informed Cabinet that he would be undertaking a number of visits in Pembrokeshire later that week, which were aligned with his five

priorities. The programme included a school visit focused on Free School Meals, a round table with energy companies at Pembrokeshire college and meetings with students. The First Minister would also be meeting the leader of the WLGA and on Friday he, alongside the Cabinet Secretary for North Wales and Transport, would be meeting Local Authority leaders from North Wales and other representatives.

Item 3: Senedd Business

3.1 Cabinet considered the contents of the Plenary Grid and noted that voting time was scheduled for 5:45pm on Tuesday and around 5:35pm on Wednesday.

3.2 The Trefnydd and Chief Whip reminded Cabinet that Stage 4 of the Senedd Cymru (Members and Elections) Bill would be taking place on Wednesday 8th May.

Item 4: Council Tax Reform

4.1 The Cabinet Secretary for Finance, Constitution and Cabinet Office introduced the paper, which asked Cabinet to note the outcome of the Phase 2 consultation on Council Tax reform and, in terms of next steps, decide which timeframe to implement reforms.

4.2 The Phase 1 consultation in 2022 had set expectations for Council Tax reform in Wales and significant progress had been made since then. The Phase 2 consultation in November proposed a range of approaches along with choices for implementation timelines.

4.3 A range of systems had been set out in the paper, underpinned by detailed analysis from the Institute for Fiscal Studies (IFS).

4.4 Cabinet agreed to implement reforms on 1st April 2028. However, it was important to amend the Local Government Finance (Wales) Bill to reflect this implementation date.
