**ATISN 11814 – GCSE 2017**

Thank you for your email of 5 December to the Welsh Government for information under the Freedom of Information Act 2000. I have interpreted your request as follows:

**For 2017 please provide data sets for all mainstream secondary and Middle schools, year 11, GCSE results showing:-**

**The broad medium (Welsh/English) of each school.**

**The number of pupils in year 11 for each school.**

**The 3 year EFSM % level for each school.**

**The number of pupils NOT Eligible for free school meals in the 2017 GCSE year group.**

**The number of pupils who achieved A\*-C in the following subjects:-**

**English language**

**Mathematics**

**Maths. Numeracy.**

**Science.**

**Please show for each school the number who entered GCSE Welsh first language (language only)**

**The number who passed GCSE Welsh first language (language only) at A\*-C.**

**Please show the number of pupils who attained the Level 2 threshold inclusive of Maths, Eng (lang) or Welsh (lang)**

**Please show the number of pupils who attained Level 2 inclusive threshold including Maths and Eng Lang but NOT Welsh lang. (In order to have a fair comparison between WM and EM schools)**

**Please show the number of pupils who attain 5 A\*-A GCSE passes for each school.**

**Show the number of pupils who attained A\*-A in the following subjects:-**

**Maths (either)**

**English Language.**

**Welsh Language.**

**Science. (any)**

**Show, for each school, the number of pupils entered for at least one Modern Foreign Language.**

**Show the number of pupils who passed at least one MFL at A\*-C.**

**Wherever a \* (denoting numbers between 1-4) appears in a column, please provide a total for the actual numbers in that column (so that I can allocate a reasonable average figure to \* numbers).**
