Annex 1

Section 22: Information intended for future publication.

The Welsh Government believes that Section 22 is applied in relation to the requested information. Section 22 of the Freedom of Information Act is subject to the public interest test. This means that in order to withhold information under its provisions, any personal interest of the requester notwithstanding, it has to be shown that the public interest in withholding the information outweighs that in releasing it.

Public interest arguments in favour of disclosure

The general presumption of openness and transparency, which the Freedom of Information Act aspires to.

Public interest arguments against disclosure

The intended publication date is in the not too distant future.

The Welsh Government acknowledges the public interest in openness and transparency, which is why the First Minister has previously written to all Assembly Members confirming that details of Ministers' meetings with external organisations and attendance at engagements would be published to the Welsh Government website quarterly from January 2017. The first four quarters are available on the Welsh Government website and the information requested will be published during the next tranche in early April 2018.

Therefore, we believe the public interest would be better served in the information being published at the appropriate time. To that end, I believe the information in relation to Ministerial diaries should be withheld under s22 of Act.
