[hepgorwyd adran 40(2)] – I think it would be safer to move the cif date further forward - if the Regs are called to committee and the Plenary is pushed forward we won't have much to spare when you consider Easter recess. It would be safer to have a cif date of end of June (29th). This would be unlikely to cause further delays to the implementation as the Commissioner would take at least a few months to work on compliance notices in anycase.
