Requests for Information – ATISN references 12002 & 12057

Thank you for your requests, which were received by the Welsh Government on 1 and 8 February respectively and which are set out at Annex 1. Please accept my apology for the delay in responding.

I have set out a summary of the information held by the Welsh Government below:

Complaint 1

A complaint was raised by a company director about the conduct of the then Minister for Education in relation to comments made about the University of Wales. The complaint was not upheld.

Complaint 2

A complaint was raised by an Assembly Member about a perceived conflict of interest under the Ministerial Code. The Minister for Education subsequently decided to resign his position as Minister for Education.

Complaint 3

A complaint was raised by a member of the public about comments made by the then Minister for Public Services during a Plenary debate on legislation relating to the use of e-cigarettes in public places. The complaint was not upheld.

Complaint 4

A complaint was raised by a former secondee to the Welsh Government between 2008 - 2010 about the conduct of the then Minister for Education. The complaint was not upheld.
