Request for Information – reference ATISN 12451; Harlech Castle, High Level Walkways

Thank you for your request which we received by email on 27 June 2018 about Harlech Castle. You asked for information held by us relating to:

- (1) A list of training, courses and qualifications in relation to risk assessment held (at the time) by the person who undertook the last assessment of the walls at Harlech Castle
- (2) A copy of the risk assessment guidance and associated forms/templates (at the time) applied during the last assessment of the walls at Harlech Castle
- (3) Information on the original height of the upper walls (this may have informed the artists impression in the postcard ref: CP420489
