Thank you for your email. I cannot say thank you for your response since your note did not address the issue which was the topic of my email to you but merely reiterated your decision. You indicate that your decision and the reasoning behind it can be questioned in the courts. However, you did not provide any indication of 'the reasoning behind it'. The public (especially those adversely affected by the decision) has a right to know what that reasoning was. Was it a considered, evidence-based assessment and, if so, what was the evidence? Or was the decision based on a vague notion of 'balance' or 'public good' that carries no evidential weight.

Since you did not provide this information, I would be grateful if you could indicate where it is available for public scrutiny.
