## **MERTHYR CHRISTIAN CENTRE, FORMERLY KNOWN AS MERTHYR TYDFIL SYNAGOGUE**

Thank you for your email of 5 March requesting files and correspondence relating to the listing of the former Synagogue known as Merthyr Christian Centre, Merthyr Tydfil. I note that you have also asked that if these records are now archived with another body, you would like to know when the records were transferred and the name of the organisation that now holds the archive.

I enclose a copy of the list descriptions dated 16 October 1978 and 13 January 1988. The Welsh Government's Information and Records Management Unit is responsible for recording the location of our files, and has advised that the files that would have held all the documentation and correspondence concerning both listings have been destroyed. I can confirm that we hold no other information concerning either listing.
