Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer Cefnffordd yr A470, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarnau penodedig o'r gefnffordd oherwydd y tebygrwydd o berygl i'r cyhoedd.

The Welsh Ministers, as traffic authority for the A470 Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be restricted because of the likelihood of danger to the public.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A470 (Cyfnewidfa Coryton, Caerdydd i fan i'r gogledd o Gyfnewidfa Ffynnon Taf, Rhondda Cynon Taf) (Terfyn Cyflymder 50 mya Dros Dro) 2019 a daw i rym ar 8 Mawrth 2019.

1. The title of this Order is the A470 Trunk Road (Coryton Interchange, Cardiff to north of Taffs Well Interchange, Rhondda Cynon Taf) (Temporary 50 mph Speed Limit) Order 2019 and it comes into force on 8 March 2019.

"exempted vehicle" ("*cerbyd esempt*") means:

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(2); and

(1) 1984 p.27; amnewidiwyd adran 14 gan adran 1(1) o Ddeddf Traffig Ffyrdd (Cyfyngiadau Dros Dro) 1991 (p.26) ac Atodlen 1 iddi. ystyr “y gefnffordd” (“*the trunk road*”) yw Cefnffordd yr A470 Caerdydd i Langurig;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfyngiad

3. Ni chaiff neb yrru unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 50 milltir yr awr ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Gorchymyn hwn.

Cymhwyso

4. Nid yw'r cyfyngiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y mae arwyddion traffig yn ei dangos.

Atal Dros Dro

5. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau ar y darnau o'r gefnffordd a ddisgrifir yn yr Atodlen wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiad a bennir yn erthygl 3 yn weithredol.

6. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” means the A470 Cardiff to Llangurig Trunk Road.

Restriction

3. No person may drive any motor vehicle, other than an exempted vehicle, at a speed exceeding 50 miles per hour on the lengths of the trunk road specified in the Schedule to this Order.

Application

4. The restriction in article 3 applies only during such times and to such extent as indicated by traffic signs.

Suspensions

5. Any statutory provisions restricting the speed of vehicles on the lengths of the trunk road described in the Schedule to this Order are suspended during such times as the restriction specified in article 3 is in operation.

Duration of this Order

6. The maximum duration of this Order is 18 months.

LIMIT) ORDER 2019**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary due to the likelihood of danger to the public due to a defective safety barrier on the A470 trunk road between Coryton Interchange and Taffs Well Interchange.

The effect of the Order is to impose a temporary 50 mph speed limit on the lengths of the A470 trunk road described in the Schedule to this Notice.

The Order is expected to come into force on 8 March 2019 and operate for a maximum duration of 18 months.
