Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Ffordd Fynediad Gwaith Dur yr A4810 (Queen's Way), wedi eu bodloni y dylid cyfyngu ar draffig a'i wahardd ar ddarnau penodedig o'r ffordd fynediad oherwydd y tebygolrwydd o berygl i'r cyhoedd.

The Welsh Ministers, as traffic authority for the relevant length of the A4810 Steelworks Access Road (Queen's Way), are satisfied that traffic in specified lengths of the access road should be prohibited and restricted by reason of the likelihood of danger to the public.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Ffordd Fynediad Gwaith Dur yr A4810 (Queen's Way) (Llanwern, Casnewydd) (Terfynau Cyflymder Dros Dro a Chlirffordd) 2018 a daw i rym ar 15 Mehefin 2018.

1. The title of this Order is The A4810 Steelworks Access Road (Queen's Way) (Llanwern, Newport) (Temporary Speed Limits and Clearway) Order 2018 and it comes into force on 15 June 2018.

ystyr "cerbyd esempt" ("*exempted vehicle*") yw:

"access road" ("*ffordd fynediad*") means the A4810 Steelworks Access Road (Queen's Way) as specified in the Schedules to this Order;

ystyr “cerbyttffordd” (“*carriageway*”) yw'r darn hwnnw o'r ffordd fynediad y bwriedir i gerbydau traffig dramwyo arni ond nad yw'n cynnwys cilfan;

ystyr “ffordd fynediad” (“*access road*”) yw Ffordd Fynediad Gwaith Dur yr A4810 (Queen's Way) fel y'i pennir yn yr Atodlenni i'r Gorchymyn hwn;

ystyr “llain ymyl” (“*verge*”) yw unrhyw ran o'r ffordd fynediad nad yw'n gerbyttffordd nac yn gilfan; ac

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lloedd cartref y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

(2) Mae unrhyw gyfeiriad yn y Gorchymyn hwn at erthygl neu Atodlen â rhif yn gyfeiriad at yr erthygl neu'r Atodlen sy'n dwyn y rhif hwnnw yn y Gorchymyn hwn.

Gwaharddiadau a Chyfyngiadau

3. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 30 milltir yr awr ar y darn o'r ffordd fynediad a bennir yn Atodlen 1.
4. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 40 milltir yr awr ar y darnau o'r ffordd fynediad a bennir yn Atodlen 2.
5. Ni chaiff neb yrru unrhyw gerbyd modur yn gyflymach na 50 milltir yr awr ar y darnau o'r ffordd

“*carriageway*” (“*cerbyttffordd*”) means that length of the access road which is intended for the passage of vehicular traffic but excludes a lay-by;

“*exempted vehicle*” (“*cerbyd esempt*”) means:

- (a) any vehicle being used by the emergency services; and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“*special forces*” “*special forces*” (“*lluoedd arbennig*”) means those units of the home forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director, and

“*verge*” (“*llain ymyl*”) means any part of the access road which is not a *carriageway* or lay-by.

(2) Any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.

Prohibitions and Restrictions

3. No person may drive any motor vehicle at a speed exceeding 30 miles per hour on the length of the access road specified in Schedule 1.
4. No person may drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the access road specified in Schedule 2.
5. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of the

Esemptiadau

8. Ni fydd dim yn erthygl 6 yn gymwys:

- (a) er mwyn atal cerbyd sy'n aros ar unrhyw gerbyttfordd cyhyd ag sy'n angenrheidiol i'r cerbyd gael ei ddefnyddio mewn cysylltiad â'r canlynol:
 - (i) unrhyw waith adeiladu neu waith dymchwel;
 - (ii) symud unrhyw rwystr i draffig;
 - (iii) cynnal a chadw, gwella neu ailadeiladu'r ffordd fynediad neu osod, codi, cynnal a chadw, addasu neu atgyweirio ar y ffordd fynediad neu gerllaw iddi unrhyw garthffos neu unrhyw brif bibell neu gyfarpar ar gyfer cyflenwi nwy, dŵr neu drydan neu unrhyw gyfarpar cyfathrebu electronig fel y'i diffinnir ym mharagraff 5 o Atodlen 3A i Ddeddf Cyfathrebiadau 2003(2);
- (b) i gerbyd a ddefnyddir at ddibenion yr heddlu, y frigâd dân neu'r gwasanaeth ambiwlans;
- (c) i gerbyd a ddefnyddir yng ngwasanaeth awdurdod lleol yn unol â phwerau neu ddyletswyddau statudol; a
- (d) i gerbyd sy'n stopio pan fo'r person sydd â rheolaeth arno'n gwneud y canlynol:
 - (i) pan fydd yn ofynnol yn ôl y gyfraith iddo stopio;

6. Except as provided by article 8, no person may cause or permit any vehicle to stop on the length of the access road specified in Schedule 4 to this Order except on the direction or with the permission of a police constable, police community support officer or civil enforcement officer

7. No person may cause or permit any vehicle to stop on any verge immediately adjacent to any part of the carriageway comprised in the lengths of the access road specified in Schedule 4 for the purpose of selling goods from that vehicle.

Suspension

8. Nothing in article 6 applies:

- (a) so as to prevent a vehicle waiting on any carriageway for so long as may be necessary to enable the vehicle to be used in connection with:
 - (i) any building operation or demolition;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the access road or the laying, erection, maintenance, alteration or repair in or near the access road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any electronic communications apparatus as defined in paragraph 5 of Schedule 3A to the Communications Act 2003(2).
- (b) to a vehicle being used for police, fire brigade or ambulance purposes;
- (c) to a vehicle being used in the service of a local authority in pursuance of statutory powers or duties, and
- (d) to a vehicle stopping when the person in control of it:
 - (i) is required by law to stop;
 - (ii) is obliged to stop in order to avoid an accident, or

40 MPH Speed Limit

That length of the eastbound carriageway of the access road that commences from a point 206 metres east of the centre of the Glan Llyn signal controlled junction to a point 41 metres east of the centre of the Newport Galvanisers signal controlled junction.

That length of the westbound carriageway of the access road that commences from a point 173 metres east of the centre of the Air Products side road access to a point 206 metres east of the centre of the Glan Llyn signal controlled junction.

SCHEDULE 3

50 MPH Speed Limit

That length of the eastbound carriageway of the access road that commences from a point 41 metres east of the centre of the Newport Galvanisers signal controlled junction to a point 10 metres west of the centre of the North Row Junction.

That length of the westbound carriageway of the access road that commences from a point 10 metres west of the North Row Junction to a point 173 metres east of the centre of the Air Products side road access.

SCHEDULE 4

Clearway

That length of the access road that commences from a point 28 metres east of the Longditch Roundabout perimeter to a point 10 metres west of the North Row Junction, a total distance of 5 kilometres.

THE A4810 STEELWORKS ACCESS ROAD (QUEEN'S WAY), (LLANWERN, NEWPORT) (TEMPORARY SPEED LIMITS AND CLEARWAY) ORDER 2018

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary to ensure the safety of the travelling public until a permanent traffic Order is introduced on the A4810 Steelworks Access Road (Queen's Way), (Llanwern, Newport) in the City of Newport.

Y darn hwnnw o'r ffordd fynediad sy'n ymestyn o bwynt 28 o fetrau i'r dwyrain o berimedr Cylchfan Longditch hyd at bwynt 206 o fetrau i'r dwyrain o ganol cyffordd Glan Llyn a reolir gan signalau.

The effect of the Order will be to:

- i. impose a 30 mph speed limit along the length of the access road specified in Schedule 1 to this Notice;
- ii. impose a 40 mph speed limit along the lengths of the access road specified in Schedule 2 to this Notice;
- iii. impose a 50 mph speed limit along the lengths of the access road specified in Schedule 3 to this Notice, and
- iv. create a clearway in that length of the access road specified in Schedule 4 to this Notice.

The temporary prohibition and restrictions, the extent of which will be signed accordingly, are expected to come into force at 00:01 hours on 15 June 2018 and remain in force for a maximum duration of 18 months or until a permanent traffic order is in force.

That length of the westbound carriageway of the access road that commences from a point 173 metres east of the centre of the Air Products side road access to a point 206 metres east of the centre of the Glan Llyn signal controlled junction.

SCHEDULE 3

50 MPH Speed Limit

That length of the eastbound carriageway of the access road that commences from a point 41 metres east of the centre of the Newport Galvanisers signal controlled junction to a point 10 metres west of the centre of the North Row Junction.

That length of the westbound carriageway of the access road that commences from a point 10 metres west of the North Row Junction to a point 173 metres east of the centre of the Air Products side road access.

SCHEDULE 4

Clearway

That length of the access road that commences from a point 28 metres east of the Longditch Roundabout perimeter to a point 10 metres west of the North Row Junction, a total distance of 5 kilometres.
