Request for Information – ATISN 13354

Thank you for your request for information dated 14 August. You asked for:

- Statistics on how many applications for apprenticeships there were in 2018- 2019 in Wales.

The Welsh Government does not receive any information on apprenticeship applications and therefore holds no information caught by your request. The statistical information we do hold on apprenticeships is published via [Stats Wales](#). Please note the link allows you to review data from previous years and sift data using the embedded tabs. The data for 2018-19 is still being verified and will not be available until approximately February 2020.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:

SK9 5AF. However, please note that the Commissioner will not normally investigate a complaint until it has been through our own internal review process.

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response. We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
