Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A4042, wedi eu bodloni y dylid gwahardd traffig ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A4042 Trunk Road, are satisfied that traffic on specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), 14(4) ac 124 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), a pharagraff 27 o Atodlen 9 iddi, yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1), 14(4) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4042 (Cylchfan Caerllion, Casnewydd i Gylchfan Cwmbrân, Torfaen) (Gwahardd Cerbydau Dros Dro) 2019 a daw i rym ar 7 Medi 2019.

1. The title of this Order is the A4042 Trunk Road (Caerleon Roundabout, Newport to Cwmbran Roundabout, Torfaen) (Temporary Prohibition of Vehicles) Order 2019 and it comes into force on 7 September 2019.

ystyr "cerbyd esempt" ("*exempted vehicle*") yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

Prohibition

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Revocation

5. The A4042 Trunk Road (Grove Park Roundabout to Caerleon Roundabout, Newport) (Temporary Prohibition of Vehicles) Order 2019(2) is revoked.

Duration of this Order

6. The maximum duration of this Order is 18 months.

**THE A4042 TRUNK ROAD (CAERLEON

ROUNDAABOUT, TORFAEN) (TEMPORARY
PROHIBITION OF VEHICLES) ORDER 2019**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A4042 trunk road between Caerleon Roundabout, Newport and Cwmbran Roundabout, Torfaen.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the lengths of the A4042 specified in the Schedule to this Notice. The alternative route arrangements are also outlined therein.

The temporary prohibition, which will be signed accordingly, is expected to first come into force on 7 September 2019 and operate intermittently overnight (20:00 – 06:00 hours) for a maximum duration of 18 months. Whenever possible, notice of closures will be displayed approximately one week in advance.

4. The length of the A4042 that extends from its junction with the northern side of Croes-y-Mwyalch Roundabout to its junction with the southern side of Crown Roundabout, Torfaen. (Local access to be maintained southbound from Cwmbran Roundabout to point of closure).

5. The length of the A4042 that extends from its junction with the northern side of Crown Roundabout to its junction with the southern side of Turnpike Roundabout, Torfaen. (Local access to be maintained northbound from Croes-y-Mwyalch Roundabout and southbound from Cwmbran Roundabout to points of closure).

6. The length of the A4042 that extends from its junction with the northern side of Turnpike Roundabout to its junction with the southern side of Edlogan Way Roundabout, Torfaen. (Local access to be maintained northbound from Croes-y-Mwyalch Roundabout and southbound from Cwmbran Roundabout to points of closure).

7. The length of the A4042 that extends from its junction with the northern side of Edlogan Way Roundabout to its junction with the southern side of Cwmbran Roundabout, Torfaen. (Local access to be maintained northbound from Croes-y-Mwyalch Roundabout to point of closure).

Alternative Routes

The alternative routes will be signed with appropriate diversion signs and will vary depending on destination and when a particular length of the A4042 described above is temporarily closed to traffic.

During closures of the lengths of the A4042 described in paragraphs 1 and 2 of the Schedule, the alternative route for vehicles less than 4.8 metres in height is via the A4042, B4591 and B4596 Caerleon Road.

The alternative route for vehicles over 4.8 metres is via the A4042, B4591, B4596 Caerleon Road, B4237 and the east or westbound M4 as necessary.

Alternative routes for all other closures will be available via the A4042 Heidenheim Drive, A4051 Malpas Road and A4051 Cwmbran Drive, as appropriate.
