Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o Gefnffordd yr A40, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A40 Trunk Road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddwyd iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Commencement and Interpretation

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A40 (Croesfan Reilffordd Llanymddyfri, Llanymddyfri, Sir Gaerfyrddin) (Gwahardd Cerbydau Dros Dro) 2019 a daw i rym ar 24 Hydref 2019.

1. The title of this Order is the A40 Trunk Road (Llandoverly Level Crossing, Llandoverly, Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2019 and it comes into force on 24 October 2019.

2. In this Order:

ystyr "cerbyd esempt" ("*exempted vehicle*") yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

ystyr "cyfnod y gwaith" ("*works period*") yw'r cyfnod hwnnw sy'n dechrau am 22:00 o'r gloch ar 24 Hydref 2019 ac sy'n dod i ben pan gaiff yr

"the trunk road" ("*y gefnffordd*") means the A40 Swansea to Manchester Trunk Road;

“works period” (“*cyfnod y gwaith*”) means that period commencing at 22:00 hours on 24 October 2019 and ending when the temporary traffic signs have been permanently removed.

Prohibition

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road at Tywi Avenue, Llandovery, Carmarthenshire that extends from a point 20 metres north of Llandovery level crossing to a point 20 metres south of that level crossing.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration for this Order is 18 months.

(CROESFAN REILFFORDD LLANYMDDYFRI,

(GWAHARDD CERBYDAU DROS DRO) 2019**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A40, neu gerllaw iddi, wrth groesfan reilffordd Llanymddyfri, Llanymddyfri, Sir Gaerfyrddin.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys ac ar gyfer y gwaith, rhag mynd ar y darn o'r A40 sy'n ymestyn am 20 o fetrau bob ochr i groesfan reilffordd Llanymddyfri yn Rhodfa Tywi, Llanymddyfri.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de fydd mynd ar yr A40 tua'r de-orllewin i Ashfield, ar yr A4069 tua'r dwyrain i Llangadog ac ar yr A4069 tua'r gogledd-ddwyrain i Llanymddyfri: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gogledd.

Disgwylir y bydd y gwaharddiad dros dro yn dod i rym am 22:00 o'r gloch ar 24 Hydref 2019 ac yn aros mewn grym hyd 05:50 o'r gloch ar 25 Hydref 2019 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn unrhyw waith a ailamserlennir.

**THE A40 TRUNK ROAD (LLANDOVERY
LEVEL CROSSING, LLANDOVERY,
CARMARTHENSHIRE) (TEMPORARY
PROHIBITION OF VEHICLES) ORDER 2019**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A40 trunk road at Llandovery level crossing, Llandovery, Carmarthenshire.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the length of the A40 that extends for 20 metres either side of Llandovery level crossing at Tywi Avenue, Llandovery.

The alternative route for southbound vehicles will be via the south-westbound A40 to Ashfield, the eastbound A4069 to Llangadog and the north-eastbound A4069 to Llandovery: vice versa for northbound vehicles.

It is expected that the temporary prohibition will come into force at 22:00 hours on 24 October 2019 and remain in force until 05:50 hours on 25 October 2019 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the dates specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
