## ATISN 13541 – Prisoner Healthcare

Thank you for your request under the Freedom of Information Act 2000, which I received on 29 October 2019. You asked for:

• A breakdown of how much funding is given to the Welsh Government from the UK Government for prisoner healthcare in Wales for 2018-19.

The Welsh Government does not receive funding from the UK Government for prisoner healthcare on an annual basis. In 2014-15 the Welsh Government received a recurrent transfer into the Welsh Block of £2.544m to support prisoner healthcare in public prisons in Wales. No additional specific funding has been provided to Welsh Government (by the UK Government) for prison healthcare in 2018-2019.

Betsi Cadwaladr University Health Board has direct funding arrangements in place in North Wales with the Ministry of Justice for HMP Berwyn. Any queries regarding the funding received for HMP Berwyn would need to be directed to Betsi Cadwaladr University Health Board or HM Prison and Probation Service.

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response. We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
