We are mindful that you have set a date for us to respond to your letter of 7th March; however, you will also appreciate we need to understand how your letter is impacted by the decision already taken by the Welsh Government in 2015 confirming that those elements of the Barry Renewable Energy Project that bring it within Schedule 2 to the EIA Regulations did not require an EIA based on the screening opinion prepared by the planning authority. The only new element is a metal water tank.
