**Request for Information – ATISN 14193**

I wrote to you on 31 July regarding your request for information. You asked:

1. Since 2015, how much money in total has the Welsh Government loaned to Tidal Power Plc, Tidal Lagoon (Swansea Bay) Plc and Tidal Lagoon Plc.
2. If any money has been loaned to the above companies, have any of the loans been repaid? If not, does the Welsh Government expect to have any of the loans repaid and has it asked for the loans to be repaid.

I confirm the Welsh Government holds some information caught by your request. No Welsh Government loan has been awarded to Tidal Power plc and therefore we do not hold information in that regard.

We provided a £1.25m commercial loan to Tidal Lagoon (Swansea Bay) Plc in February 2015, which has been repaid.

We provided a £1.25m commercial loan to Tidal Lagoon Plc in March 2018. We do not hold any information on the repayment of this loan as the term does not end until 31 December 2022.

The Welsh Government does not hold on record any other information in relation to your specific questions above. However, we can advise that as with all commercial loan facilities provided by the Welsh Government to third parties, we would expect those to be repaid in accordance with the terms and conditions set out within the loan facility.
