ATISN 14497 – Covid19 Testing

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 29 October. Your request relates to covid19 test results, specifically:

- *Please could you advise how many COVID test results have been lost, and resulting in either a retest or unnecessary self-isolation and resultant lost working days.*
- *Please could you also advise the average time for people receiving test results?*

Our response

Welsh Government does not hold information on the number of COVID test results which have been lost and as a consequence, result in either a retest or unnecessary self-isolation and resultant lost working days. Next steps

The request you sent me contains personal information about you - for example, your name and address. We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
