ATISN 14598 – Request for information in relation to Conwy County Borough Council area.

Thank you for your request which we received on 26 November 2020 in which you asked for the following information:

- How many residential and nursing care homes in the Conwy Local Authority area reported at least one positive case of Covid-19 in August, September and October 2020 separately?

According to our records, the number of care homes in Conwy Local Authority who reported at least one confirmed case of Covid-19 in each month is as follows:

August 2020 - 1 home
September 2020 - 10 homes
October 2020 - 12 homes

Of these there are 21 unique homes in total as some homes reported cases in more than one of these months. Please note this data only reflects information notified to Care Inspectorate Wales.

It may be helpful for you to be aware that we are now publishing data on the number of care homes by Local Authority that have informed us of a confirmed case of Covid-19 within the last 7 days and within the last 28 days. We only began publishing this data on 27
