### **ATISN 14971: Direct Oral Anticoagulants Rebate Scheme**

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 08 March. You requested information related to Direct Oral Anticoagulants Rebate Scheme, specifically:

- 1. Please confirm or deny if rebate schemes applying to direct oral anticoagulants (DOACs) have been available to the NHS in Wales at any point in 2020-21.*
- 2. Please confirm or deny if rebate schemes applying to rivaroxaban specifically have been available to the NHS in Wales at any point in 2020-21.*
- 3. Please supply details of any rebate schemes applying to each of the four NICE-approved DOACs which are available on the NHS in Wales.*

### **Our Response**

The Welsh Government has made no arrangements for rebate schemes related to DOACs and is unable to confirm or deny whether such arrangements have been put in place by individual health boards.
