Request for Information – ATISN 15273

I wrote to you on 29 June regarding your request for information.

Information requested

You asked for the following information in relation to road-building costs:

1. The total financial cost of the Flintshire 'Red Route' road-building project up until it's suspension as announced by the Welsh Government on 22/06/21.
2. A breakdown of how funds were spent on the 'Red Route' planning up until it's suspension as announced by the Welsh Government on 22/06/21.
3. The financial cost of all road-building projects across Wales that have now been put on hold as a result of the decision to suspend road-building as announced by the Welsh Government on 22/06/21 (from their start to their suspension on 22/06/21).

Our Response

I confirm that the Welsh Government does hold some information caught by your request.

1. £4,341,748.09
2. North East Wales Area Based Transport Study = £290,924.44
Planning Stage WeITAG = £30,086.48
WeITAG Stage 1 Study = £212,442.54
WeITAG Stage 2 Study = 1,872,406.72

Technical and commercial advisor's services to prepare and progress the next stage of design development including project management, undertaking surveys, and procurement of designers = £1,965,974.39
