**ATISN 15462 – RENEWABLE ONSHORE WIND ENERGY DEVELOPMENTS.**

Thank you for your request which I received on 25 August. You asked for:

- Information on any large scale wind energy applications that were withdrawn either before or after submitting an application? If withdrawn at pre app stage or scoping request stage.

The information caught by your request constitutes environmental information so has been considered for disclosure under the Environmental Information Regulations 2004 (EIRs). I have decided none of the information described in the enclosed disclosure list is exempt from disclosure.

You will, however, need to search through the web-site to find the information you seek in respect to onshore wind farms.

The UK Secretary of State may also have received some applications which were subsequently withdrawn, details of Development Consent Orders can be accessed at:

Again you will need to search through the web-site to find the information you seek in respect of onshore wind farms.

The Welsh Government does not hold information on applications submitted to Local Planning Authorities and subsequently withdrawn, you would need to contact each individual LPA to obtain any information they hold in respect of their administrative areas.

Please note: the Welsh Government is facing unprecedented challenges during the coronavirus (COVID-19) pandemic. The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response. We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
