

## DEDDF CYNLLUNIO GWLAD A THREF 1990

### GORCHYMYN CAU PRIFFYRDD (PROMENÂD Y DWYRAIN, PORTHCAWL, PEN-Y-BONT AR OGWR) 2022

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. ## TOWN AND COUNTRY PLANNING ACT 1990

### THE STOPPING UP OF HIGHWAYS (EASTERN PROMENADE, PORTHCAWL, BRIDGEND) ORDER 2022

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The stopping up will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by Bridgend County Borough Council on 22 December 2021 with reference number P/21/835/FUL described in Schedule 2 to this Notice.

The Stopping Up of Highways (Eastern Promenade, Porthcawl, Bridgend) Order 2022 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge during normal opening hours at Porthcawl Library, 13 Church Place, Porthcawl CF36 3AG or may be obtained free of charge from the address below quoting reference qA1532675, or viewed online on the Welsh Government's website at <https://gov.wales/stopping-orders>.

If a person is aggrieved by the Order, on the ground that:

- it is not within the powers of the Act; or
- a procedural requirement of the Act has not been complied with;

that person may, within 6 weeks of 23 June 2022 make an application for the purpose to the High Court.
