

**GORCHYMYN CEFNFFORDD YR A465 (Y  
FFORDD YMUNO TUA'R GORLLEWIN WRTH  
GYFNEWIDFA BRYN-MAWR, BLAENAU  
GWENT) (GWAHARDD CERBYDAU DROS  
DRO) 2023**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A465, neu gerllaw iddi, wrth Gyfnewidfa Bryn-mawr, Blaenau Gwent.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys neu ar gyfer y gwaith, rhag mynd ar y darn o'r ffordd ymuno tua'r gorllewin wrth Gyfnewidfa Bryn-mawr.

Y llwybr arall yw ymuno â cherbyttffordd tua'r dwyrain yr A465 wrth Gyfnewidfa Bryn-mawr, mynd at Gyffordd Saleyard, ymadael a dychwelyd ar gerbyttffordd tua'r gorllewin yr A465.

Daw'r Gorchymyn i rym ar 1 Mawrth 2023. Disgwylir y bydd y gwaharddiad dros dro yn weithredol yn ysbeidiol dros nos (20:00 – 06:00 o'r gloch) o 1 Mawrth 2023 am gyfnod o 18 mis ar y mwyaf. Bydd hysbysiadau yn cael eu harddangos cyn pob cyfnod pan fwriedir cau'r ffordd.

**THE A465 TRUNK ROAD (WESTBOUND  
ENTRY SLIP ROAD AT BRYNMAWR  
INTERCHANGE, BLAENAU GWENT)  
(TEMPORARY PROHIBITION OF VEHICLES)  
ORDER 2023**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A465 trunk road at Brynmawr Interchange, Blaenau Gwent.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services or for the works, from proceeding on the length of the westbound entry slip road at Brynmawr Interchange.

The alternative route is to join the A465 eastbound carriageway at Brynmawr Interchange, proceed to Saleyard Junction, exit and return via the A465 westbound carriageway.

The Order comes into force on 1 March 2023. The temporary prohibition is expected to operate intermittently overnight (20:00 – 06:00 hours) from 1 March 2023 for a maximum period of 18 months. Notices will be displayed in advance of all planned closures.
