Thank you for your request which was received on 5 October 2023. You asked for information, for which responses are provided at Annex 1.

For some of the information requested, I have reached the conclusion that it will cost more than the appropriate limit established in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 to consider this part of your request. The appropriate limit specified for central government is £600. When calculating whether or not your request exceeds appropriate limit, I am allowed to consider the time it is likely to take to establish if we hold the information, locate the information, retrieve the information and extract it. If these tasks are estimated to take more than 24 hours of working time, the limit will have been exceeded.

You have requested information relating to total purchased electricity and natural gas costs. Energy accounts for Welsh Government Transport Group are managed in a number of places with different organisations who manage the accounts.

To respond to your request would require locating, retrieving and extracting data from multiple energy accounts and organisations. It is estimated that this would take over a week to locate and extract invoices. With an estimate of 2 minutes to check each invoice (before even locating relevant invoices for each account) based on 1000 invoices would take 33 hours.

Because this exceeds the appropriate limit established in the Freedom of Information and Data Protection (Appropriate limit and Fees) Regulations 2004, I have decided not to process that part of your request.

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:
