Re: Registration Query

Thank you for sending the information HIW has requested regarding the services that you are currently providing, can I apologise that we have not got back to you sooner with an answer, but the services you provide are very complex and HIW need to make sure that it makes the correct decision with regards to registration.

The information you have provided suggests the following:

- Services are provided by Medical Practitioners.
- There are no overnight beds provided to patients.
- Some, or all, of the funding is provided by the Area Planning Board, Public Health Wales, Powys Teaching Health Board or a combination of these.

The definition contained within section 2(4) of the Care Standards Act 2000 provides an exemption from registration if any of the services provided by medical practitioners are in the pursuance of the National Health Service (Wales) Act 2006.

Some, or all, of your funding for the Kaleidoscope Project Services comes from the Area Planning Board, Public Health Wales, or Powys Teaching Health Board from ring fenced health monies, or a combination of these sources. HIW's view is that at least some of the services being provided by medical practitioners at these settings are in pursuance of the National Health Service (Wales) Act 2006 and therefore **registration of these services is not required**.

To determine whether the services that are lead by G4S require registration we would require the following information:

- A copy of the agreement between G4S and Kaleidoscope.
