

**GORCHYMYN CEFNFFORDD YR A477
(SANCLÉR, SIR GAERFYRDDIN I GILGETI,
SIR BENFRO) (GWAHARDD CERBYDAU DROS
DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adrann 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A477, neu gerllaw iddi, rhwng Sanclér, Sir Gaerfyrdin a Chilgeti, Sir Benfro.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd rhag mynd ar y darn o gefnffordd yr A477 sy'n ymestyn o'i chyffordd ag ochr orllewinol Cylchfan Sanclér hyd at ei chyffordd ag ochr ddwyreiniol Cylchfan Cilgeti.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r gorllewin yw mynd ar yr A40 tua'r gorllewin i Gylchfan Pont Canaston, yr A4075 tua'r de i Cross Hands, yr A4115 tua'r dwyrain i'w chyffordd â'r A478 a'r A478 tua'r de i ailymuno â'r A477 wrth Gylchfan Cilgeti: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r dwyrain.

Daw'r Gorchymyn i rym ar 8 Gorffennaf 2024. Disgwylir y bydd y gwaharddiad dros dro yn weithredol dros nos (20:00 – 06:00 o'r gloch) rhwng 8 a 12 Gorffennaf 2024, neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A477 TRUNK ROAD (ST CLEARS,
CARMARTHENSHIRE TO KILGETTY,
PEMBROKESHIRE) (TEMPORARY
PROHIBITION OF VEHICLES) ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A477 trunk road between St Clears, Carmarthenshire and Kilgetty, Pembrokeshire.

The effect of the Order is to temporarily prohibit all vehicles from proceeding on the length of the A477 trunk road that extends from its junction with the western side of St Clears Roundabout to its junction with the eastern side of Kilgetty Roundabout.

The alternative route for westbound vehicles is via the westbound A40 to Canaston Bridge Roundabout, southbound A4075 to Cross Hands, eastbound A4115 to its junction with the A478 and southbound A478 to rejoin the A477 at Kilgetty Roundabout: vice versa for eastbound vehicles.

The Order comes into force on 8 July 2024. The temporary prohibition is expected to operate overnight (20:00 – 06:00 hours) from 8 to 12 July 2024, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the dates specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any changes to times and dates will be displayed before any rescheduled work begins.
