Please accept my apologies that my submissions have created additional work for you, as I fully appreciate the pressures your team is under.

I can respond as follows on the individual applications.

Stad Plas Hen (apologies again, yes, this should have been for Design and Construction)

- Please outline the reasons why this work is required.

A recent scheme has improved the catchment of surface water on the Stad Plas Hen estate, but unfortunately, following completion of the works, it became apparent that the outlet system is in very old and in poor condition with damage and breaks in the pipe run. This has caused the new surface water system serving the estate not to be effective, as it does not outlet satisfactorily.

Additionally, since the scheme has been implemented there is evidence of overland flows from the nearby fields contributing to the flood risk of properties.

As a consequence, despite the recent scheme, there are 5 properties that remain at risk of flooding.

- Please provide details of the proposed works to be undertaken and identify how these

will improve flood risk.

The proposal is to repair and/or replace the carrier drain that serves as an outlet to the recently completed surface water scheme. Also to provide some additional pipework to intercept overland flows from the nearby fields. With improved interception of overland flows and with an upgraded outlet drain, these measures will reduce to flood risk to properties on the Stad Plas Hen Estate.

Hi all

I have gone through the 5 applications for the Small Scale Works Grant. I am afraid that the evidence provided is not sufficient to make an informed decision as to the issue here. On the application form, there are the following questions:

- Please outline the reasons why this work is required
- Please provide details of the proposed works to be undertaken and identify how these will improve flood risk

The responses provided for each of the applications are very limited. For the first question, it appears that a standard response has been cut and paste into each. These two questions are where the LA needs to explain in some detail why the problem is occurring at that specific location, how many properties are being impacted and how the proposed works will directly benefit each location. Where possible, a brief summary of any near misses and action taken by the LA might help the application.

For most of the applications, the supporting evidence is insufficient for us to make an informed decision. Furthermore, the NRW mapping provided often doesn't show any obvious risk to the properties. This doesn't necessarily preclude the application going ahead, but we need more evidence to show us what the maps are failing to show i.e. which properties are impacted and why.

Lastly, Stad Plas Hen also says it is for Design only on the application, but I would guess this is incorrect as it is asking for £156k?

These are large schemes, totalling over half a million in value, so the case for investment needs to be strong.

Is it possible to provide answers to the 2 questions above for all of the schemes ASAP?
