

**GORCHYMYN CEFNFFORDD YR A40 (HEOL
FAWR, ABERGWAUN, SIR BENFRO)
(GWAHARDD CERBYDAU DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A40, neu gerllaw iddi, yn Abergwaun, Sir Benfro.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys neu ar gyfer y gwaith, rhag mynd ar y darn o gefnffordd yr A40 sy'n ymestyn o bwynt y tu allan i rif 2 Heol Fawr hyd at bwynt y tu allan i rif 23 Heol Fawr, Abergwaun.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de yw ar hyd yr A487 y Wesh tua'r gorllewin, yr A40 Ffordd Osgoi Abergwaun tua'r de a'r A487 Heol Fawr tua'r gogledd: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gogledd.

Daw'r Gorchymyn i rym ar 14 Hydref 2024. Disgwylir y bydd y gwaharddiad dros dro yn weithredol o 08:00 o'r gloch ar 14 Hydref hyd 16:00 o'r gloch ar 16 Hydref 2024, neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 12 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A40 TRUNK ROAD (HIGH STREET,
FISHGUARD, PEMBROKESHIRE)
(TEMPORARY PROHIBITION OF VEHICLES)
ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A40 trunk road at Fishguard, Pembrokeshire.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services or for the works, from proceeding on the length of the A40 trunk road that extends from a point outside number 2 High Street to a point outside number 23 High Street, Fishguard.

The alternative route for southbound vehicles is via the westbound A487 West Street, southbound A40 Fishguard Bypass and northbound A487 High Street: vice versa for northbound vehicles.

The Order comes into force on 14 October 2024. The temporary prohibition is expected to operate from 08:00 on 14 October until 16:00 hours on 16 October 2024, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the period specified above it will remain valid for a maximum period of 12 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any changes to times and dates will be displayed before any rescheduled work begins.
