Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 16A o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4076 (Hamilton Terrace, Aberdaugleddau, Sir Benfro) (Gwahardd Cerbydau Dros Dro) 2024 a daw'r Gorchymyn hwn i rym ar 10 Tachwedd 2024.

2. Yn y Gorchymyn hwn—

(1) 1984 p. 27. Mewnosodwyd adran 16A gan adran 1(1) o Ddeddf Rheoleiddio Traffig Ffyrdd (Digwyddiadau Arbennig) 1994 (p. 11). Yn rhinwedd O.S. 1999/672, ac adran 162 o Ddeddf Llywodraeth Cymru 2006 (p. 32) a pharagraff 30 o Atodlen 11 iddi, mae'r swyddogaethau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.

The A4076 Trunk Road (Hamilton  
Terrace, Milford Haven,  
Pembrokeshire) (Temporary  
Prohibition of Vehicles) Order  
2024

Made 4 November 2024

Coming into force 10 November 2024

The Welsh Ministers, as traffic authority for the A4076 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited by reason of a relevant event, namely the Remembrance Sunday memorial service, being held on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A4076 Trunk Road (Hamilton Terrace, Milford Haven, Pembrokeshire) (Temporary Prohibition of Vehicles) Order 2024 and this Order comes into force on 10 November 2024.

Interpretation

2. In this Order—

(1) 1984 c. 27. Section 16A was inserted by the Road Traffic Regulation (Special Events) Act 1994 (c. 11), section 1(1). By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these functions are now exercisable by the Welsh Ministers in relation to Wales.

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw—

- (i) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion yr heddlu, y gwasanaeth tân neu'r gwasanaeth ambiwlans;
- (ii) unrhyw gerbyd sy'n cael ei ddefnyddio mewn cysylltiad â gwaith ar y ffordd neu oleuadau neu arwyddion traffig neu waith brys i unrhyw garthffos neu i unrhyw brif bibell neu gyfarpar ar gyfer cyflenwi nwy, dŵr neu drydan, neu gyfarpar telathrebu yn y darn o'r ffordd o dan sylw, neu mewn unrhyw dir cyfagos;
- (iii) unrhyw gerbyd sy'n cael ei ddefnyddio gan un o swyddogion awdurdodedig y digwyddiad i gefnogi'r digwyddiad ac am resymau diogelwch;

ystyr “cyfnod y digwyddiad” (“*event period*”) yw'r cyfnod sy'n dechrau am 10:00 o'r gloch ar 10 Tachwedd 2024 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A4076 Hwlfordd i Aberdaugleddau.

## Gwaharddiad

3. Ni chaiff neb, yn ystod cyfnod y digwyddiad, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o'r gefnffordd a elwir yn Hamilton Terrace, Aberdaugleddau, Sir Benfro sy'n ymestyn o'i chyffordd â Priory Street hyd at ei chyffordd â The Rath.

## Cymhwyso

4. Nid yw'r gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

## Cyfnod para'r Gorchymyn hwn

5. Bydd y Gorchymyn hwn yn para am ddiwrnod ar y mwyaf.

“event period” (“*cyfnod y digwyddiad*”) means that period commencing at 10:00 hours on 10 November 2024 and ending when the temporary traffic signs are permanently removed;

“exempted vehicle” (“*cerbyd esempt*”) means—

- (i) any vehicle being used for police, fire or ambulance services purposes;
- (ii) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned;
- (iii) any vehicle used by an authorised event official in support of and for reasons of the safety of the event;

“the trunk road” (“*y gefnffordd*”) means the A4076 Haverfordwest to Milford Haven trunk road.

## Prohibition

3. No person may, during the event period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road known as Hamilton Terrace, Milford Haven, Pembrokeshire that extends from its junction with Priory Street to its junction The Rath.

## Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

## Duration of this Order

5. The maximum duration of this Order is one day.
