HISTORY

Two kites found dead in a field near Knighton and received by Welsh Government in March 2020. A further kite found in a nearby field in April 2020. The birds were received frozen at Carmarthen VIC by from an examined on 21/05/20 and placed in refrigerator and examined following day.

Carcase/ Red Kite 3 Male 877 Good Mild grams in bag

Red Kite 1 was received in a signed brown paper evidence bag with a plastic seal A124682. The signed part of the bag has been retained. The bird had wing-tags on both wings with yellow A on both tags. It had a leg ring on right leg BTONATHISTORY MUSEUM GV34172

Red Kite 2 and 3 were in plastic bags within a brown paper evidence bag sealed with yellow bag seal A135143 and the signed part of the bag has been retained. There were no wing tags or leg rings

NECROPSY FINDINGS

RED KITE 1.

The body cavities were open and contained large numbers of maggots. The liver, kidneys, lungs, heart and pectoral muscles were missing and leg muscle was collected for toxicology.

Alimentary System: The gizzard contained a small amount of fibrous content

RED KITE 2 AND 3.

The carcases were intact.

Alimentary System: The gizzard of each bird contained a small amount of soft brown content.

No abnormalities of the remaining body systems were seen.

WORK IN PROGRESS

Matrix (M) gene RRT-PCR - screening test for M gene of all influenza A viruses x 2, West Nile Virus RNA - avian x 2

Tissues retained frozen: Muscle, Stomach content (Red kite 1); Liver, Kidney, Muscle, Proventriculus and Gizzard with content (Red kite 2 and 3).

COMMENT

Red Kite 1 had been fed on by maggots and much tissue was missing. It was not possible to determine the cause of death or to determine body condition. The bird had only fibrous material in the gizzard. Red Kites 2 and 3 were in good body condition. The cause of death was not established. The birds had a small amount of brown soft content in their stomachs. Please let us know if samples should be submitted for toxicology, once AI results are received and assuming they are negative.
