Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A470, wedi eu bodloni y dylid cyfyngu ar draffig a'i wahardd ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrrdd 1984(1), yn gwneud y Gorchymyn hwn.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A470 (Cyfnewidfa Coryton, Caerdydd) (Terfyn Cyflymder 10 mya Dros Dro a Dim Goddiweddyl) 2024 a daw'r Gorchymyn hwn i rym ar 5 Ionawr 2025.

ROAD TRAFFIC, WALES

The A470 Trunk Road (Coryton Interchange, Cardiff) (Temporary 10 mph Speed Limit and No Overtaking) Order 2024

Made 23 December 2024

Coming into force 5 January 2025

The Welsh Ministers, as traffic authority for the A470 trunk road, are satisfied that traffic on a specified length of the trunk road should be restricted and prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A470 Trunk Road (Coryton Interchange, Cardiff) (Temporary 10 mph Speed Limit and No Overtaking) Order 2024 and this Order comes into force on 5 January 2025.

Interpretation

2. In this Order—

“exempted vehicle” (“cerbyd esempt”) means—

(1) 1984 c. 27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c. 26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

(a) unrhyw gerbyd sy'n cael ei ddefnyddio at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1) neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

(b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrnu gan berson sydd am y tro yn ddarostyngedig i orchymynion aelod o luoedd arfog y Goron, sy'n aelod o'r luoedd arbennig—

(i) ac sydd wedi ei hyfforddi i yrnu ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol; neu

(ii) at ddiben hyfforddi person i yrnu cerbydau ar gyflymderau uchel;

ystyr “cyfnod y gwaith” (“*works period*”) yw'r cyfnod sy'n dechrau am 20:00 o'r gloch ar 5 Ionawr 2025 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A470 Caerdydd i Llangurig;

ystyr “luoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r luoedd cartref y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

Cyfyngiad a gwaharddiad

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrnu unrhyw gerbyd modur, ac eithrio cerbyd esempt, yn gyflymach na 10 milltir yr awr ar y darn cyfan o gerbytffordd gylchredol y gefnffordd wrth Gyfnewidfa Coryton yn Sir Caerdydd.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, ddefnyddio cerbyd na chaniatáu i gerbyd, ac eithrio cerbyd esempt, gael ei ddefnyddio yn y fath fod fel ei fod yn goddiweddyd unrhyw gerbyd arall ar y darn o'r gefnffordd a bennir yn erthygl 3 ar yr adegau hynny pan fo'r cyfyngiad y cyfeirir ato yn erthygl 3 yn weithredol.

(a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984 Act(1) or in connection with the works giving rise to this Order;

(b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

(i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or

(ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*luoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A470 Cardiff to Llangurig trunk road;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 hours on 5 January 2025 and ending when the temporary traffic signs are permanently removed.

Restriction and prohibition

3. No person may, during the works period, drive any motor vehicle, other than an exempted vehicle at a speed exceeding 10 miles per hour on the entire length of the circulatory carriageway of the trunk road at Coryton Interchange in the County of Cardiff.

4. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk road specified in article 3 during such times as the restriction referred to in article 3 is in operation.

Atal Dros Dro

5. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau ar y darn o'r gefnffordd wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiad a bennir yn erthygl 3 yn weithredol.

Cymhwysyo

6.—(1) Ni fydd y cyfyngiad a'r gwaharddiad yn erthyglau 3 a 4 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw derfyn cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

Cyfnod Para'r Gorchymyn hwn

7. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

Suspensions

5. Any statutory provisions restricting the speed of vehicles on the length of the trunk road are suspended during such times as the restriction specified in article 3 is in operation.

Application

6.—(1) The restriction and prohibition in articles 3 and 4 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limit imposed by this Order applies to an exempted vehicle.

Duration of this Order

7. The maximum duration of this Order is 18 months.
