Dear Minister,

We the undersigned wish to express our profound concern in relation to the recently reported activities at Hybu Cig Cymru.

As former Directors and Board Members it is with great sadness that we are witnessing an organisation that has achieved so much on behalf of levy payers in establishing Welsh Lamb and Beef as world-renowned products, lose credibility and fall considerably short of what the red meat industry should expect from the millions of pounds that it contributes to HCC.

We are concerned that as a result of what appears to us to be a breakdown at Governance level the current HCC leadership has failed to lead a cohesive and unified group. We are aware of numerous resignations at both senior personnel and board level membership.

We believe that the situation needs to be addressed urgently and would strongly urge that you launch an independent review of the governance at HCC.
