I hope this email finds you well.

I am writing to attach a marked up version of the draft MoU for your review. You will see that we have made some amendments in tracked changes and there are suggested changes and queries in the comments.

It may be helpful to note that some of the comments relate to whether the MoU will be live after 13 December 2024. This is due to new legislation which will bring Physician Associates (PAs) and Anaesthesia Associates (AAs) under regulation of the GMC; meaning our role will change to that of a multiprofessional regulator on that date. We can keep an eye on the progress of drafting the agreement, as it may be that if the draft is ready close to December 13, it would be better to be held off for a short time until the legislation is live. This means that the agreement would reflect our new role and would not need to be updated with this information at a later date.
