This is the information I would normally expect to be submitted with a stage 1 assessment although I would expect the LB's that had been shown by the ZTV not to have views to the proposed development to be included, so they can be discounted from further study. I assume that you have also done similar work in regard to RHP&Gs and SMs. Whilst it is unlikely given the distance from the proposed development that there will be significant impacts, it is worth checking if any designated historic assets inside 10km and in the ZTV have a designed view towards it, when they should be included in any further assessment.

If it is determined that the impact of the proposed development from the registered historic landscape needs to be assessed this should be carried out using the methodology given in "The Setting of Historic Assets in Wales" and not by the ASIDOHL methodology which would not be appropriate in this case.
